- 1 Drawings of the forgings must be got approved from the undersigned before doing forging.
- 2 Raw material of forging must be offered for inspection along with material test certificates to the Competent Person.
- 3 Physical and chemical testing of finished forging must be done in approved laboratory in presence of the Competent Person of this Inspectorate.
- 4 Forgings must be offered for verification and final inspection / stamping on completion of forgings.
- 5 Heat treatment of the forging to be carried out as per the requirement of the related code in the heat treatment furnace having current certified calibration certificate by the firm in presence of Competent Person.
- 6 You have to comply In-house Heat Treatment Furnace and In-house Physical and Chemical testing laboratory within the period of six months.
- 7 You shall have to carryout manufacturing of forgings as per instructions issued from time to time either by Competent Person or by Inspecting Authority.
- 8 This permission can be withdrawn at any time without giving notice if the workmanship is found unsatisfactory.
- 9 If any change in firm's name, Director & technical staff must be informed to this office at the earliest.
- 10 You are hereby instructed to get it renewed before 60 days from the expiry of this certificate.
